**PROCEDURES FOR NOMINATION OF DIRECTOR**

Any shareholder (other than the person to be proposed) may nominate a person to stand for election as Director at the general meeting in accordance with article 120 of the Articles of Association of the Company. Any shareholder wishing to do so must serve (i) a written notice of intention to propose such person for election as Director; (ii) a notice executed by that person of his/her willingness to be elected; and (iii) the information of that person as required to be disclosed under rule 13.51(2) of the Listing Rules to the Company’s principal place of business in Hong Kong at 23/F, China Merchants Tower, Shun Tak Centre, 168-200 Connaught Road Central, Hong Kong between the period, which shall be at least 3 days, commencing from the date after the despatch of the notice of the general meeting appointed for such election and ending on (and excluding) the date that is 10 clear business days prior to the date of such general meeting. The Company shall issue an announcement and/or a supplementary circular, if applicable, to inform the shareholders the biographical details of the candidate proposed if a valid notice to propose a person to stand for election as Director is received.
